Read all of this leaflet carefully before you start taking this medication, as it contains important information. Please keep it, as you may need to read it again.

Your medical cannabis treatment

You have been given this leaflet because you have been prescribed an unlicensed medical cannabis product.

Important:

- This information is only to be provided to patients who have been prescribed or dispensed Martindale Pharma medical cannabis products.
- This medicine has been prescribed for you only. Do not pass it on to others. It may harm them, even if their signs of illness are the same as yours.
- This medicine should only be used as prescribed by your doctor.
- Do not take this medication if you are allergic to any of the ingredients.

This leaflet will cover important product information, and what to be aware of during treatment, for the specific type of medical cannabis extract you have been prescribed. The name of your medicine is:

Martindale Pharma Full spectrum standardised extract, T10:C100 oral drops

Super critical carbon dioxide extraction.

Product description

30mL, amber coloured liquid oral drops, in glass bottles with a white cap and safety ring. Each bottle comes with a graduated dropper.

Storage

Store below 30 degrees Celsius (protected from light and tightly closed).

Shelf life

24 months.

Dosing information

The right dose of a medical cannabis treatment varies from patient to patient and is therefore determined by the prescribing physician following consultation with you. Your starting dose may depend on a number of factors, including whether you have previously used similar products. Please be aware that it may take a number of weeks for your doctor to find the right strength and dose of product to suit you.

Side effects

Like all medicines, this medicine may cause side effects, although not everybody gets them. If you experience any side effect when taking this medicine, please speak to your doctor or another appropriate medical professional as soon as possible.

Reporting of side effects

If you get any side effects, talk to your doctor or pharmacist. This includes any possible side effects not listed in this leaflet. You can also report side effects directly via the Yellow Card Scheme (see page 1 for details).

Warnings

Special warnings and precautions

This medicine may make you feel sleepy. If this happens do not drive or use tools or machinery.

Do not drive while taking this medicine until you know how it affects you. Do not drive if you feel sleepy, dizzy, unable to concentrate or make decisions, or if you have blurred or double vision.

Do not drink alcohol whilst taking this medicine.
